Anti- Ragging Committee

- a) The duty of the Anti-ragging Committee is to ensure compliance with the provisions of BPUT Regulations on curbing the menace of ragging as well as the provisions of law for the time being in force concerned with ragging and also to monitor and oversee the performance of the Anti- ragging squad in prevention of ragging in the Institution and shall punish a student found guilty as per the regulation of BPUT according to the enquiry report along with recommendations submitted by antiragging squad.
- b) The Committee shall prepare posters preferably multi-coloured indicating the provision of law, punishment etc. which will be prominently displayed on all Notice Boards of all departments, hostels and other buildings as well as at vulnerable places.

Anti-Ragging Squad.

- a) The duty of Anti- Ragging Squad is to maintain vigil, and remain mobile, alert and active at different vulnerable points such as College, Canteen, Corridors, Hostels, Café, Bus-Stop, etc at all times.
- b) It shall be the duty of the Anti-Ragging Squad to make surprise raids to hostels, and other places vulnerable to ragging.
- c) It shall also be the duty of the Anti-Ragging Squad to conduct an on-the-spot enquiry into any incident of ragging referred to it by the Head of the Institution or any member of the faculty or any member of the staff of any student or any parent or guardian or any employee of a service provider and the enquiry report along with recommendations shall be submitted to the Anti-Ragging Committee for action as per regulations of BPUT.
- d) The Anti-Ragging Squad shall conduct such enquiry following a fair and transparent procedure and the principles of natural justice giving adequate opportunity to the student or students accused of ragging and to other witnesses.
